November 20th (Thursday), 21st (Friday), 2025 Venue: Nara Centennial Hall (Nara)

## 1. Aim of the Meeting:

Through the gathering of specialists in the field of OLED science and technology for thorough discussion and debate, the 41st Meeting of the Japan OLED Forum aims to advance the further development of the science, applied research, and practical use of OLEDs. This Meeting aims to build a common base for OLED-related science and technology while at the same time educating talented researchers and engineers through presentation and discussion of recent research and developments regarding OLEDs, create a common venue for industrial and academic cooperation through nationwide participation, and encourage the research development and business development of OLED displays and lighting by inspiring and guiding its participants toward realizing the future of OLEDs. With these aims in mind, presentations and in-depth discussions will be held regarding the fundamental research of OLEDs and the development of high-value OLED products.

In addition, to commemorate the 20th anniversary of the JOF, we have invited a number of up-and-coming professors who have been active in the field both in Japan and abroad, in addition to those who have supported the development of the field since its early days, to speak at the "20th Anniversary Symposium". We will also welcome you to the Banquet with special hospitality. "Author interviews" will be held at the venue of the social event, providing a rare opportunity to talk directly with the speakers. ## 8. Submission outline for general presentations

- **8.1** Submission requirements: Contributors must be regular members or student members of the Forum.
- 8.2 Student Oral Presentations

We have a student oral presentation slot to provide educational support for students who wish to pursue this field of research. Through oral presentations, Q&A sessions, and poster discussions, we hope that students will reconfirm the position of their own research and increase their motivation by organizing the background, objectives, results, and issues of their research from an educational perspective.

- 8.5 Manuscript

Please submit a 2 page A4 version manuscript (including figures and tables) as a PDF file. If your paper is accepted, the manuscript will be printed in black and white and the proceedings will be published. The submitted data will also be made available to regular members and student members on the web. Manuscripts and lectures will be in Japanese in principle. In addition, the abstract part of the manuscript will be published on the web at the same time as the program is released (after Tuesday, October 21), and the entire manuscript will be published on the web for one month from Thursday, November 13.

#### 8.6 Selection of abstracts

The Forum adopts a peer review system for selecting abstracts based on the following criteria. If the content of an abstract is not in accordance with the purpose of the Forum, it might not be selected. Submissions specifying short oral presentations and student oral presentations will also be accepted. Both the general and short oral presentations and student oral presentations will be part of the poster discussion.

- (1)Originality of the thesis is not required.
- ②Abstract content shall be able to withstand discussion at the Forum and be reproducible.



3 Based on the review, abstracts will be selected as either general oral presentations or short oral presentations or student oral presentations or rejected.

#### 8.7 Outstanding Presentation Award

The Japan OLED Forum Outstanding Presentation Award is given to the member who displays excellence in the general presentations during the Meetings in autumn and spring. The award and a research scholarship (\(\frac{\pma}{2}\)200,000) are presented to the best speaker under 35 years of age. In addition, the "Student Presentation Encouragement Award" will be given to the student who makes an outstanding presentation among the student oral presentations. - 2) Notification of acceptance of the dissertation will be sent by e-mail by Monday, October 20.
- ③Speakers should also register for the Meeting in the same manner as non-speakers.

  - (1) Information in the Proceedings is deemed to be publicly available when it is made available on the web.
  - (2) The copyright to work appearing in the abstract will belong to both the Forum and the author.
  - (3) The author bears responsibility for the content of the abstract and the presentation registration form.
  - 4) Changes to abstracts after the submission deadline and withdrawal of presentations is not permitted.
